



What's Blooming in Session this Month

Dear Friend,

We've finally made it to the May flowers after enduring the April showers. What is blooming for you this Spring? I have some bills from the House that I'm currently working to bring into bloom. Read on to learn more about these pieces of legislation, as well as some grants to help further grow nonprofit organizations.

Legislative Update



The last time we spoke, I had just inherited House Bills to carry in the Senate. After my successes with Senate Bills moving to the House chamber, I was ready to tackle House legislation. Here's an update on some House Bills I'm carrying and currently working to move in the Senate:

- ❖ HB1363: enhances protections for workers from gender-related violence in the workplace and ensures employers provide training regarding gender-related violence, and investigates any complaints from employees regarding it.
- ❖ HB1557: Requires music venues to have a staff member trained in the administration of Narcan and to be stationed

around the perimeter of the venue to prevent overdoses while protecting the administrator from liability when acting in good faith.

- * HB3116: Requires school boards to set up a training once every two years for all school personnel to educate them on how to spot homelessness within students, and properly refer them for resources.
- ❖ HB1166: Ensures entities bidding on state contracts have their Equal Pay Certification in the 2 prior calendar years before applying for the bid, and makes the list of entities holding their Equal Pay Certification publicly available.

Illinois Criminal Justice Information Authority: Legal Assistance for Crime Victims Grant



The following NOFO is available to public agencies or nonprofits that specialize in providing pro bono legal services. Studies have found that victims who received legal assistance had a lower chance of revictimization by their intimate partner and improved independence. This grant is in an effort to expand the network of agencies providing legal assistance to these victims. The deadline to apply is May 15th, 2023 by 5pm and more information and the application can be found here.

ICJIA: Violence Against Women Sexual Assault Services Grant

The following NOFO is available for a sexual assault coalition that has a statewide network of providers. This grant will allow the grantee to connect and distribute subgrants to core providers in their network and conduct structured monitoring of all subgrantees to ensure parameters and core services are being met. The deadline to apply is May 12th, 2023 by 5pm, and more information can be found here.



IDHS Firearm Violence Prevention Technical Assistance Provider



The Illinois Department of Human Services is looking for Violence Prevention Technical Assistance Providers to apply as a designated entity to provide training for nonprofit organizations that are being awarded Firearm Violence Prevention Grants. Technical Assistance providers will be responsible for gathering with the grantees to gauge their current understanding of working in violence prevention and to give training based on where the organizations could grow more knowledge. The trainings would surround violence prevention services itself, management of violence prevention professionals, understanding referral services, and capacity building such as technical assistance or grant management. Technical Assistance Providers will be paid via the
